Performance Provides Celebration, Education, Inspiration

Brooke Hull usually teaches her students at Judy Dollenmayer Studio of Dance about movement. But this year she taught them something about being moved as well.

Inspired by her mom's personal battle with breast cancer, Brooke decided to put on a dance showcase to raise money and awareness of the disease. Dancing for Life, as the program was called, featured inspired, original performances in jazz, lyrical, tap and hip-hop from over 65 dancers in the studio's Elite Company.

Through ticket sales and local sponsorships, the event raised more than \$10,000 – all of which was donated to the Mount Carmel Foundation's Women's Health Fund, which provides free programs and support for breast cancer patients and mammograms for underserved women throughout central Ohio.

Childhood Challenge Fuels a Dream

As a star freshman on her high school soccer team, it wasn't unusual for Amanda Utzinger to come home feeling beat up after a hard afternoon of practice. But when her parents recognized that her pain level and the swelling and stiffness that came with it might be caused by more than hard work and hustle, they sought help. It turned out Amanda had systemic Juvenile Rheumatoid Arthritis.

"The nurses who cared for me during my several hospitalizations – sometimes for as long as two weeks at a time – were like angels to me," Amanda recalled. "Their concern with my physical needs, as well as compassion about my feelings and worry over what I was missing at school, really touched me, and that's when I realized how important the role of a nurse can be."

That experience led her to enroll at the Mount Carmel College of Nursing and pursue a career in the field. She even earned the *Tammy Weidner Memorial Scholarship*, the Delores Street Ohio Contractors Association Memorial Scholarship and the Monica and Stephen Walter Scholarship thanks to generous donations to the Mount Carmel Foundation.

Welcome Home

Much-Needed Support for New Moms

No one disputes that having a baby is a life-changing event. But most people – including new moms themselves – don't know just *how* life-changing until they get home from the hospital.

That's when reality hits. And sometimes it hits hard. From the overwhelming amount of work and worry to the underwhelming amount of sleep, those first few weeks can be quite a shock to the system.

That's why Mount Carmel created the Welcome Home program. Funded in part by the Mount Carmel Foundation, it features a free, hour-long, in-home visit by a specially trained Mount Carmel Registered Nurse during which babies get a thorough check-up and assessment, and moms get some personal attention and reassurance. It's also a great opportunity for moms to have new questions answered and learn some more about their babies' growth and development.

More than 1,200 central Ohio moms who deliver their babies at Mount Carmel receive Welcome Home visits each year. And regardless of the circumstances, it's a big help in the transition home.

"I had no idea that my blood pressure was out of control," said new mom, Rochelle Mayo. "I just figured it was my body going back to normal after childbirth. This program is priceless for women that may need some extra help or that peace of mind that your baby and you are ok."

“Ruby Sue”

A Green Light on the Road to Recovery

Thirty-nine years old is too young to have two strokes. But that’s just what happened to Noelle Eldridge. With left-side paralysis, inpatient rehabilitation was her ticket to returning home to her 12-year-old daughter, her animals and her job as a customer service representative.

The rehabilitation staff at Mount Carmel West worked with Noelle on regaining strength in her left hand and leg so that she could walk and work on a computer again. But there are only so many things they can do in rehab to approximate real life. That’s when they call on Ruby Sue.

Ruby Sue isn’t a therapist in the strictest sense of the word. She’s a gateway to therapy. She’s a Ruby Red Pearl Subaru Outback that was donated to the program through the Mount Carmel Foundation to give patients the opportunity to put their re-learned skills to use before returning home. On Noelle’s last week in rehab, she got a ride from Ruby Sue to a nearby restaurant to have her first real-world experience before heading home.

“I hadn’t been outside in eight weeks,” Noelle recalled. “I had to work on simple things like getting in and out of the car, working with my walker on uneven surfaces and just being back in the community again. It was a great experience and gave me a lot of confidence that I could do things for myself again.”

“While much healing takes place inside the walls of our hospital, thriving happens when someone returns to their life,” said Mount Carmel Clinical Coordinator Camille Milligan. “Through home visits and community outings like Noelle had, we offer safe, therapeutic ways to facilitate that return. And Ruby Sue is vital to what we do.”

Interpreting Services Equipment

Facilitating Communication, Improving Care

They say communication is the key to any relationship. That's doubly true when the relationship is between a medical professional and a patient. Understanding a patient's concerns and accurately diagnosing and treating his or her condition are completely dependent upon clear communication. And when those two parties don't speak the same language, it's a considerable challenge.

That's why Mount Carmel created its Interpreting Services Department, which provides system-wide, around-the-clock interpretation in 14 languages and dialects, including sign language, to patients and their families. And thanks to a grant from the Mount Carmel Foundation, the department has added online video capabilities to make its services even more widely available and more easily accessible.

"Video interpreting is becoming more and more prevalent in the hospital setting," said Program Director Todd Huff. "It provides a great service to our patients and staff, and, thanks to the investment the Foundation has allowed us to make in additional equipment, we're able to bring it to more people at a reasonable cost."

"I've had the opportunity to use the new online language interpreter service twice in the last couple of weeks and I love it," said Belinda Johnson, an emergency department nurse at Mount Carmel West. "Having the patient be able to see the interpreter onscreen rather than passing a phone back and forth is much more comfortable and efficient. It helps us do our jobs better and makes the experience more effective for the patient as well. It's new technology that everyone appreciates."

National Conference Poster Presentation Brings Recognition, Opportunity

Thanks to a grant from the Mount Carmel Foundation and Susan G. Komen for the Cure Columbus, three Mount Carmel nurses were able to attend this year's Academy of Oncology Nurse Navigators' Annual Navigation and Survivorship Conference in San Antonio, Texas. But it wasn't just the funding that won them the trip.

The nurse navigators at Mount Carmel's Women's Health Centers submitted an abstract on their program, titled "A Professional Model for Practice: Kolcaba's Comfort Theory and the Breast Health Nurse Navigator," which was selected for poster presentation at the conference.

The poster, which featured Mount Carmel's famous GRACE bear, outlined Mount Carmel's model of nurse navigation, including information on survivorship programs like Involvement in the Race, Komen Survivorship and Medical Advisory Boards, lymphedema clinics, and aquatic yoga and breast cancer exercise programs.

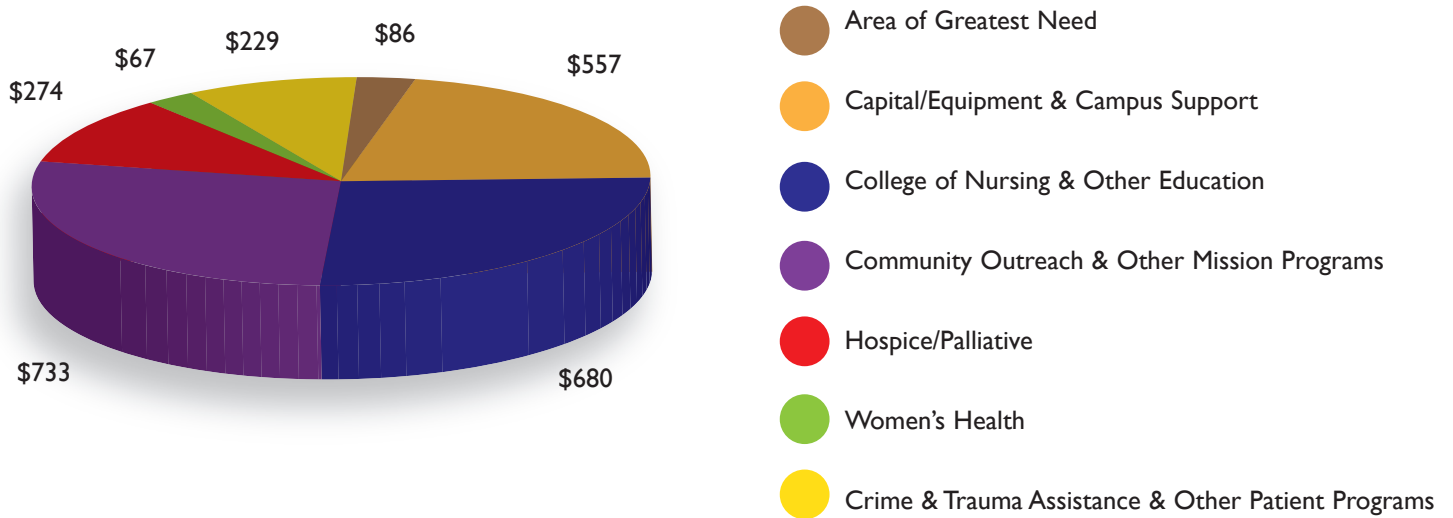

Charitable Expenditures

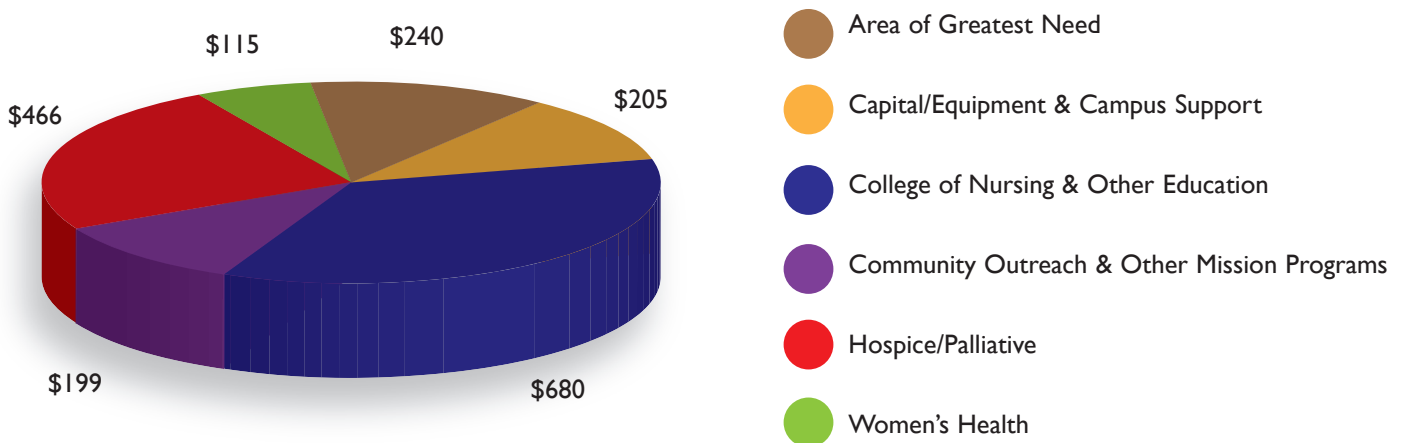
\$2,626 (In Thousands)
